

2007/2008 Goalie Equipment Policy

Deposit:

Equipment rental fees and a deposit of \$300 are required at the time of equipment checkout. The borrower is 100% responsible for any loss of equipment and for the proper care and maintenance of the equipment. Off-ice use of the equipment is strictly prohibited. Dirt, grass, concrete, and blacktop will quickly wear out both leg pads and sticks, the borrower is responsible for repair or full replacement in cases of abuse. Additional care and maintenance guides are available.

Repairs:

Minor repairs (i.e. Less than \$20) such as straps or string are the responsibility of the borrower. Receipts for minor repairs are to be to the equipment manager and will be reimbursed by the treasurer. The goalie equipment manager should be contacted if major repair or replacement becomes necessary.

Equipment Check In:

The borrower is responsible to return equipment to the goalie equipment manager within 14 days of the last scheduled game of the current season. This process is mandatory in order to check equipment, evaluate size changes, and repair/replace equipment if necessary. Goalies that do not have equipment check in will not be permitted to begin or attend tryouts. They also will not receive their volunteer deposit until check in takes place.

Equipment Provided, Rental Fees, and Ice Credits:

All ice credits to goalies (Exceptions Squirt Goalie/Skater) will be applied at the time of the second payment is due.

- The goalie must stay to the end of the season plus playoffs or have a season ending injury that is approved by the board to prevent not being charged back the credit.
- Squirt goalie/skater credit will be given back credit after completion of the season and the goalie meets the requirement of 50% goalie and 50% skater.

For Mites and U8, each head coach is supplied with goalie equipment consisting of leg pads, chest protector, blocker glove, catch glove, hockey bag, and a stick. Each coach or team representative will supply a deposit check to ensure equipment is returned.

For Squirts and U10, goalies are supplied with goalie equipment consisting of leg pads, chest protector, blocker glove, and a catch glove. Goalie sticks may be provided. Each item is rented at no cost. Full-time goalies receive a \$500 credit. Skater/Goalies receive a \$250 credit to be applied/given at seasons end, after completing the obligation of skater/goalie. Goalie skaters are recommended equipment for Squirts, U10, and above.

For Peewee and U12, goalies can request goalie from the following items: leg pads, chest protector, blocker glove, and catch glove. Each item is rented at 20% of its purchased cost. Goalies will receive a \$500 credit to help defray the cost of rental fees or

purchasing their own equipment. Goalie skates and goalie breezers are recommended equipment for Pee wee, U12, and above.

For Bantam, U14, and above; goalies can request goalie equipment from the following areas: leg pads, chest protector, blocker glove, and a catch glove. Each item is rented at 25% of its purchased cost. Goalies will receive 50% off of their final team assessment to help defray the cost of rental fees or purchasing their own equipment.

When upper level teams do not have a registered goalie, their head coach can request goalie equipment for the purpose of encouraging others to play the position and not for the benefit of one individual. Each head coach or team representative will supply a deposit check to ensure the equipment is returned.

Off Season Equipment Rental Fee:

When renting equipment during the off season, each item is rented at one-fourth of the upcoming winter seasons rental fee. Attendance at the fall equipment check-in is mandatory. Goalies that do not have their equipment checked in two weeks prior to tryouts will not be permitted to begin or participate in the tryouts.
